RESOLUTION NO. 514-2019

DECLARING ORDINANCE NO. 03-2019 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING AND ADOPTING MEASURES AND SYSTEMS TO ENSURE EFFICIENT AND EFFECTIVE IMPLEMENTATION OF THE LOCAL TB CONTROL PROGRAM OF THE MUNICIPALITY OF ROSALES, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 03-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 17 (b) (2) (iii) and Section 447 (a) (i) (iii), (2) (i) of RA 7160; and the Comprehensive and Unified Policy for Tuberculosis (Executive Order No. 187, Series of 2003);

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication pursuant to Section 59 and Section 511 of RA 7160;


