PROPOSED PROVINCIAL RESOLUTION NO. 514-2021

APPROVING THE INCLUSION OF VARIOUS PRIORITY PROGRAMS AND PROJECTS IN THE PROVINCIAL DEVELOPMENT INVESTMENT PROGRAM 2018-2027 OF THE PROVINCE OF PANGASINAN

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the inclusion of various priority programs and projects in the Provincial Development Investment Program 2018-2027 of the Province of Pangasinan as indorsed by the Provincial Development Council through PDC Execom Resolution No. 11-21;

WHEREAS, the PDIP is a financing plan and investment schedule during a 10-year planning period, which ensures that limited resources of the Province are allocated and utilized properly for the implementation of priority programs and projects geared towards achieving local and national roads, objectives and priorities;

WHEREAS, there is a need to update the PDIP to include various priority programs and projects of the Province, which are deemed necessary in the attainment of its goals and objectives;

WHEREAS, the programs and projects are proposed for funding from the Local Government Support Fund-Other Financial Assistance (LGSF-FA) to Local Government Units in Republic Act No. 11518 or the 2021 General Appropriations Act;

WHEREAS, to avail of the fund, one of the requirements is the inclusion of the programs and projects in the Local Development Investment Program and in the Annual Investment Program of the LGU as specified in Local Budget Circular No. 131 dated January 8, 2021 of the Department of Budget and Management;


WHEREAS, the inclusion of various priority programs and projects to the PDIP is geared toward the socio-economic development goals and thrusts of the Province;

WHEREFORE, in view of the foregoing, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


