DECLARING MUNICIPAL ORDINANCE NO. 5, S-2021 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE ASSISTANT VI (COMPUTER OPERATOR III) SG 12, IN THE OFFICE OF THE MUNICIPAL ACCOUNTANT OF THE EXECUTIVE DEPARTMENT, MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Municipal Ordinance No. 5, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76, 447 (a) (1) (vii) and (viii) of R.A. No. 7160;

WHEREAS, HOWEVER, the educational requirement of the position of created should be changed from bachelor's degree to completion of two-year studies in college pursuant to Memorandum Circular No. 10, S-2005 of the Civil Service Commission;


