# CERTIFICATION

#### TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on May 3, 1996 at Lingayen, Pangasinan, the following provincial resolution was approved:

#### **PROVINCIAL ORDINANCE NO. 52-96**

ORDINANCE PROHIBITING THE USE OF THE CAPITOL GROUNDS AND MARAMBA BOULEVARD AS PASTURE AREAS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF

**WHEREAS,** it has been observed that cows, goats, carabaos and some horses are being pastured in the grounds of the Capitol compound and some areas along the Maramba Boulevard;

**WHEREAS,** previously, Lingayen was noted and declared as one of the dirtiest municipalities in the country, with the Capitol grounds and the Maramba Boulevard among the forefront;

WHEREAS, amidst several notices to the owners, these cattle or domesticated mammals are still pastured making the said places dirty, undesirable and unpleasant for local visitors and tourists;

WHEREAS, there is a need to regulate the use of the subject areas to protect our parks/grounds and the environment;

**WHEREAS,** in view of the foregoing, on motion of SP Member Dionisio C. Antiniw, co-authored by SP Member Eduardo R. Perez, duly seconded, be it enacted by the Sangguniang Panlalawigan in session assembled that;

**SECTION 1.** DEFINITION OF TERMS. – For purposes of this Ordinance the hereunder terms shall mean as follows:

- **a.** Cattles shall include cows, carabaos, goats, horses and other domesticated mammals heid as property for use:
- **b.** The Owner may refer to the cattleman, the person who tends or raises the cattle, or the person who have the legal title to the subject animals.

**SECTION 2.** PROHIBITED ACTS. – It shall be unlawful for any owner to pasture cattle along the roads, parks and grounds of the Capitol compound and Maramba Boulevard:

**SECTION 3.** PENALTY CLAUSE. - Any violation of this Ordinance is punishable by the following penalties:

a. For goats and other small domesticated animals:

First Offense - P100.00/head Second Offense - P200.00/head Third Offense - P300.00/head

b. For other cattle and large animals:

First Offense - P200.00/head Second Offense - P300.00/head Third Offense - P500.00/head

- c. The impounded animals shall be redeemed by the owner upon payment of the penalty duly supported by an Official Receipt from the Provincial Treasure's office:
- d. The owner is obliged to redeem the impounded cattle/animal within a period of five (5) days. If the said cattle/animal has not been redeemed within the prescribed period, additional charges shall be as follows:
  - 1. For goat and small animals P50.00/head for every additional day.
  - 2. For large cattle and other animals P100.00 per head for every additional day.
- e. If the impounded cattle/animal has not been redeemed after a period of ten (10) days, the same shall be sold at the public auction.

**SECTION 4.** REPLEALING CLAUSE. - All ordinances, rules and regulations or part thereof, inconsistent with or in conflict with the provisions of this Ordinance are hereby repealed or modified correctly;

**SECTION 5.** SEPARABILITY CLAUSE. - If for any reason or reasons, any part or provision of this Ordinance shall be held to be invalid or unconstitutional, other parts or provisions hereof which are not affected thereby continue to be in full force and effect;

**SECTION 6.** EFFECTIVITY. - This Ordinance shall take effect after a copy hereof shall have been posted at prominent places in the Provincial Capitol, the Municipal Hall of Lingayen and the Barangay Halls of Poblacion, Maniboc and Libsong for minimum period of three (3) weeks and published in the newspaper of general circulation in the Province for a period of two (2) consecutive weeks.
