PROVINCIAL RESOLUTION NO. 522-2022

AMENDING FURTHERMORE THE INTERIM INTERNAL RULES OF PROCEDURE OF THE 10TH SANGGUNIANG PANLALAWIGAN BY HOLDING THE REMAINING SESSIONS AT THE SESSION HALL OF THE CAPITOL BUILDING

WHEREAS, the latest amendment of the Interim Internal Rules of Procedure of the 10th Sangguniang Panlalawigan provides for the holding of at least two (2) physical sessions every month but not necessarily on the 1st and 3rd Monday, with the option to have additional physical sessions should the need arise, and which session shall start at 10:00 a.m. to be held at the Training Center II, Capitol Compound, Lingayen, Pangasinan;

WHEREAS, the Sangguniang Panlalawigan has also been holding virtual sessions through video conferencing system which start at 10:00 a.m. on remaining Mondays when a physical session is not necessary;

WHEREAS, for more than two years, the Sangguniang Panlalawigan did not hold its sessions at the Session Hall of the Capitol Building in order to observe minimum public health protocols due to the pandemic;

WHEREAS, but since the Province is again placed under Alert Level 1 due to the lessening of COVID-19 cases and that several parts of the Province of Pangasinan have been recording zero active infections, the 10th Sangguniang Panlalawigan deemed it necessary to go back to its original manner of holding the remaining sessions at the Session Hall of the Capitol Building, Lingayen, Pangasinan;

WHEREAS, consequently, there is a need to amend the provision of the Interim Internal Rules of Procedure of the Sangguniang Panlalawigan by holding the remaining sessions at the Session Hall of the Capitol Building which shall start at 10:00 a.m.;
