**APPROVING SB RESOLUTION NO. 2021-327, SERIES OF 2021 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “RESOLUTION CONCURRING/APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO.2020-17, SERIES OF 2020 ENTITLED ADOPTION OF RESOLUTION ENDORSING THE REVISED ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN CALENDAR YEAR 2021 AND ENDORSING IT TO THE SANGGUNIANG BAYAN FOR APPROVAL”**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its SB Resolution No. 2021-327 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that it is passed in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

**WHEREAS**, the Local Development Council of Sta. Barbara, Pangasinan endorsed to the Sangguniang Bayan the proposed Revised Annual Investment Program for CY 2021 through MDC Resolution No. 2020-17, dated December 22, 2020;

**WHEREAS**, the LGU revised their AIP for CY 2021 to include new projects proposed to be funded from the Muniicipal Shares from the Burley and Native Tobacco Excise Tax, CY 2017, in the amount of P43,572,121.00;

**WHEREAS**, the proposed/identified projects were based on Local Budget Memorandum No. 81 dated November 4, 2020 of the Department of Budget and Management;


