APPROVING THE PROJECTS TO BE FUNDED FROM THE SHARE FROM TOBACCO EXCISE TAX PURSUANT TO LOCAL BUDGET MEMORANDUM NO. 79, DATED JUNE 14, 2019

WHEREAS, the share of the Province from the CY 2016 Collection of Excise Tax on Burley and Native Tobacco Excise Tax pursuant to RA No. 8240 as amended by RA No. 10351 is P27,655,395.00;

WHEREAS, the said amount is intended for the following projects to be distributed to tobacco farmers:

1. Farm Mechanization - Provision of Farm Machineries - 87 units hand tractor

P15,660,395.00

2. Irrigation Development Installation of Open Well Irrigation Project – 57 units

1,995,000.00

3. Construction of Warehouse Curing Barn with Office and Multi-Purpose Drying Pavements – 2 units 10,000,000.00

Total - P27,655,395.00
