**APPROVING RESOLUTION NO. 81-2020 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) 2020 OF THE MUNICIPALITY OF NATIVIDAD, PROVINCE OF PANGASINAN FOR CY 2020"**

**WHEREAS**, the Sangguniang Bayan of Natividad, Pangasinan submitted its Resolution No. 81-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Disaster Risk Reduction and Management Council during their meeting on April 2, 2020 approved the Revised LDRRMF Program CY 2020 thru MDRRMC Resolution No. 1, S-2020;

**WHEREAS**, the Revised LDRRMF Program includes the programs/projects in response to COVID-19 pandemic which will be funded from the Unexpended Calamity Fund CY 2018, 2019 and QRF 2020;

**WHEREAS**, the Local Development Council has revised the CY 2020 Annual Investment Program to include the programs and projects in response to COVID-19 pandemic funded from the unexpended QRF CYs 2018, 2019 and QRF 2020 (P3,666,729.08). This was endorsed to their Sangguniang Bayan for approval thru MDC Resolution No. 01-2020 dated April 14, 2020;
