**RESOLUTION NO. 528-2020**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR  
CALENDAR YEAR 2020 OF TAYUG, PANGASINAN INVOLVING A  
TOTAL APPROPRIATION OF P3,084,655.58 OPERATIVE IN ITS  
ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Tayug, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2020 involving total appropriations of **P3,084,655.58** which was approved on February 18, 2020 through Appropriation Ordinance No. 001, S-2020;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The full implementation of the First Tranche Salary Adjustment to all municipal officials and employees shall be in accordance with the provisions of Local Budget Circular No. 121 of the Department of Budget and Management dated January 24, 2020: *Re: Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Republic Act No. 11466;*

2. The grant of step increment to some municipal officials and employees shall be in accordance with CSC-DBM Joint Circular No. 01, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016;
3. It is hereby reiterated that the previous finding of the salary of Elma D. Jaramillo, Revenue Collection Clerk I under the Office of the Municipal Treasurer shall be adjusted from G-5/4 – P11,985.00 to G-5/3 – P11,894.00 per month; *and*
4. The appropriation for the payment of Terminal Leave Benefits (TLB) of retired LGU personnel shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.2 thereof.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 1 for Calendar Year 2020 of Tayug, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Tayug;
