APPROVING RESOLUTION NO. 2020-058 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL AIP PURSUANT TO APPROPRIATION ORDINANCE NO. 2020-003 OF THE MUNICIPALITY OF TAYUG, PANGASINAN INVOLVING AN AMOUNT OF TEN MILLION FIVE HUNDRED ONE THOUSAND EIGHT HUNDRED NINETY FIVE PESOS (P10,501,895.00)”

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Resolution No. 2020-058 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Tayug, Pangasinan has adopted and endorsed the municipality’s Supplemental Annual Investment Program No. 3 through MDC ExeCom Resolution dated April 16, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on April 24, 2020 through Resolution No. 2020-058. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

WHEREAS, the Supplemental Annual Investment Program No. 3 with an investment requirement amounting to P10,501,895.00 covers programs/projects/activities to address emergency response measures to COVID-19 pandemic. This will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA No. 11469 (The Bayanihan to Heal as One Act);


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
