APPROVING RESOLUTION NO. 2019-017 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 2 FOR CALENDAR YEAR 2019 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2019-017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan formulated the municipality's Supplemental Investment Program No. 2 covering projects to be funded from LGU's share from FY 2016 collection of Burley Tobacco Excise Tax in the amount of P27,988,103.00. This was endorsed through MDC Resolution No. 3, S-2019 dated July 15, 2019 and was subsequently approved by the Sangguniang Bayan through Resolution No. 2019-017 dated August 14, 2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the identified new projects to be funded from FY 2016 collection of Burley Tobacco Excise Tax are new projects and not included in the municipality's approved CY 2019 Annual and Supplemental Investment Programs;
