RESOLUTION NO. 531-2020

DECLARING ORDINANCE NO. 118, S-2019 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE DECLARING ALL PUBLIC AND PRIVATE OFFICES AND INSTITUTIONS LIKE SCHOOLS, HOSPITALS, CHURCHES, PUBLIC MARKET AND OTHER BUILDINGS AS WELL AS TRANSPORTATION VEHICLES IN THE MUNICIPALITY OF BASISTA, PANGASINAN SMOKE-FREE AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 118, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (3) (ii) of RA 7160; Executive Order No. 26 (Providing for Establishment of Smoke-Free Environments in Public and Enclosed Places); Section 24 of Republic Act No. 8749 (Philippine Clean Air Act of 1999); and Section 5 (a), (b), (c) (d) and (e) of Republic Act No. 9211 (Tobacco Regulation Act of 2003);

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with;


