PROVINCIAL RESOLUTION NO. 531-2021

INVITING THE NATIONAL GRID CORPORATION OF THE PHILIPPINES (NGCP), CENPELCO, PANELCO I, PANELCO III AND DECORP TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS JUNE 14, 2021 REGULAR (PHYSICAL) SESSION TO SHED LIGHT ON THE CAUSES OF THE RECENT POWER OUTAGES IN THE PROVINCE OF PANGASINAN

WHEREAS, the Luzon grid has been placed by the National Grid Corporation of the Philippines (NGCP) under red alert lately due to the thinning of power supply;

WHEREAS, the Luzon area including the Province of Pangasinan has then experienced a rotational blackout;

WHEREAS, the Sangguniang Panlalawigan would like to know if the Province of Pangasinan will be expecting power outages during the months of dry season;

WHEREAS, it is important to have a reliable power supply during this period of public health crisis to ensure effective responses to COVID-19 diagnostic tests and treatments;

WHEREAS, the presence of the electric cooperatives would go a long way to help the Sangguniang Panlalawigan in the enactment of legislative measures not only to enhance public utility services but also to identify areas of concern needing immediate attention;
