**RESOLUTION NO. 531-2022**

**DECLARING ORDINANCE NO. 2020-08 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "AN ORDINANCE CREATING ONE (1) LIBRARIAN II – SALARY GRADE 15/1, PERMANENT POSITION UNDER THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Ordinance No. 2020-08 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2020-08 of the Sangguniang Bayan of San Manuel, Pangasinan, entitled "An Ordinance creating one (1) Librarian II – Salary Grade 15/1, Permanent Position under the Sangguniang Bayan of the Municipality of San Manuel, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;




