DECLARING MUNICIPAL ORDINANCE NO. 2021-18 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF SOCIAL WELFARE OFFICER II-SALARY GRADE 15 PERMANENT UNDER THE OFFICE OF THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT, SAN MANUEL, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
