RESOLUTION NO. 534-2019

DECLARING INVALID MUNICIPAL ORDINANCE NO. 2019-03 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN ENTITLED "AN ORDINANCE ABOLISHING THE VACANT POSITION OF ADMINISTRATIVE AIDE IV (BOOKBINDER II) AND CREATING THE NEW POSITION OF ADMINISTRATIVE AIDE IV (CLERK II) AT THE LEGISLATIVE DEPARTMENT UNDER THE SECRETARY TO THE SANGGUNIANG BAYAN'S OFFICE"

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2019-03 to the Sangguniang Panlalawigan for its review and evaluation pursuant to Section 56 of RA No. 7160, otherwise known as the Local Government Code of 1991;
