ORDINANCE 130, S-2020 OF DECLARING NO. SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED **POSITION** ORDINANCE CREATING ONE (1) AGRICULTURIST П UNDER THE **OFFICE** AGRICULTURE OF THE LOCAL GOVERNMENT UNIT OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 130, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of RA 7160;

WHEREAS, the review of the Annual Budget of the Municipality for Calendar Year 2020 shows that the local government unit is still within the personal services cap. However, considering that the sanggunian created several positions in various offices of the Municipality, the personal cap under Section 325 (a) of RA 7160 should be observed during the preparation of funding for the created positions;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
