**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH THE NATIONAL NUTRITION COUNCIL FOR THE IMPLEMENTATION OF THE *TUTOK KAINAN* DIETARY SUPPLEMENTATION PROGRAM IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, the *Tutok Kainan* is part of the Dietary Supplementation Program of the National Nutrition Council which aims to prevent stunting by giving nutritious food commodities to nutritionally at-risk pregnant women and children 6-23 months old;

**WHEREAS**, the Province of Pangasinan is one of the priority areas for the implementation of the *Tutok Kainan* which focuses in providing proper nutrition and dietary supplementation to target beneficiaries in the Province of Pangasinan;

**WHEREAS**, the Program prioritizes the nutritional needs of pregnant women and the growth of their child particularly during the first 1000 days;

**WHEREAS**, the Program will help lessen malnutrition problems in the Province of Pangasinan especially at this time of pandemic;

**WHEREAS**, the Province of Pangasinan in collaboration with the National Nutrition Council shall undertake the *Tutok Kainan* Dietary Supplementation Program as an intervention in addition to its local nutrition program;

**WHEREFORE**, on motion of all Members of the Sangguniang Panlalawigan, duly seconded, it was –


