ALVIAR, JR., AND THE AFRICAN SWINE FEVER FOCAL TEAM OF THE DEPARTMENT OF AGRICULTURE, REGION I; REGIONAL TECHNICAL DIRECTOR MILDRED SALIGAN, NATIONAL MEAT INSPECTION SERVICE, REGION I; DR. JHONABETH PAJARILLAGA, CHIEF, BUREAU OF ANIMAL INDUSTRY - QUARANTINE SERVICE, REGION I; MAYOR ANTHONY C. PENULIAR OF MAPANDAN, PANGASINAN; ATTY. GERALDINE U. BANIQUED, PROVINCIAL LEGAL OFFICER; DR. JOVITO G. TABAREJOS, ACTING PROVINCIAL VETERINARIAN; AND MR. RHODYN LUCHINVAR O. ORO, PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER, TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN ON ITS OCTOBER 7, 2019 REGULAR SESSION TO APPRISE THE BODY ON THE STATUS OF AFRICAN SWINE FEVER IN THE PROVINCE OF PANGASINAN AND THE POSSIBLE MITIGATING MEASURES TO PREVENT THE ENTRY OF THE SAME, IN AID OF LEGISLATION

WHEREAS, the Sangguniang Panlalawigan is ever mindful of its functions to ensure and support the promotion of health and safety of its constituents;

WHEREAS, African Swine Fever (ASF) is a highly contagious hemorrhagic disease of pigs characterized by high fever, loss of appetite and eventually death;

WHEREAS, African Swine Fever has been spreading rapidly in some parts of the country, which include now the Province of Pangasinan, as it has been reported that a number of hogs infected with ASF from a neighboring Province were delivered in Mapandan, Pangasinan, specifically in Barangay Baloling;



RESOLVED, by the Sangguniang Panlalawigan in session assembled to invite, as they are hereby invited, Regional Director Lucrecio R. Alviar, Jr., and the African Swine Fever Focal Team of the Department of Agriculture, Region I; Regional Technical Director Mildred Saligan, National Meat Inspection Service, Region I; Dr. Jhonabeth Pajarillaga, Chief, Bureau of Animal Industry - Quarantine Service, Region I; Mayor Anthony C. Penuliar of Mapandan, Pangasinan; Atty. Geraldine U. Baniqued, Provincial Legal Officer; Dr. Jovito G. Tabarejos, Acting Provincial Veterinarian; and Mr. Rhodyn Luchinvar O. Oro, Provincial Disaster Risk Reduction and Management Officer, to a Question Hour of the Sangguniang Panlalawigan on its October 7, 2019 Regular Session to apprise the Body on the status of African Swine Fever in the Province of Pangasinan and the possible mitigating measures to prevent the entry of the same, in aid of legislation;
