DECLARING ORDINANCE NO. 2021-10 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "AN ORDINANCE FOR THE CREATION OF NURSE I, SALARY GRADE 15 WHOSE OTHER FUNCTION IS DISEASE SURVEILLANCE OFFICER, PERMANENT POSITION UNDER THE MUNICIPAL HEALTH OFFICER OF SAN MANUEL, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT




