PROVINCIAL RESOLUTION NO. 536-2019

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, OR HIS AUTHORIZED REPRESENTATIVE, TO ENTER INTO AND SIGN AN AGREEMENT WITH SICHUAN PROVINCE AND ITS INTERNATIONAL SISTER CITIES (STATES) FOR THE ESTABLISHMENT OF THE CULTURE AND TOURISM ALLIANCE FOR INTERNATIONAL SISTER CITIES (CTAISC) AND ITS CHARTER

WHEREAS, Culture and Tourism Alliance for International Sister Cities (CTAISC) is a non-governmental and non-profit organization sponsored by Sichuan Province and its international sister cities (states), local governments of Sichuan Province and their respective counterparts in order to promote cultural and tourism ties among its alliance members;

WHEREAS, the Culture and Tourism Forum shall be held on October 15, 2019 in Chengdu, Sichuan Province, China and shall be attended by the Province of Pangasinan through its authorized representative/s for the establishment of the Culture and Tourism Alliance for International Sister Cities (CTAISC) and its charter;

WHEREAS, the agreement would be an instrument for growth and further development for the Province of Pangasinan as it is designed to foster stronger friendship and deeper cross-cultural and tourism understanding among its members;

WHEREAS, one of the major activities proposed by the Culture and Tourism Alliance for International Sister Cities (CTAISC) is the holding of the Alliance Arts Festival alternately every two years to be actively participated in by all its alliance members in order to further enhance the economic development of its respective cultural and tourism industries and activities;
