APPROVING RESOLUTION NO. 21, S-2020 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF CALASIAO FOR THE YEAR 2020"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 21, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Calasiao, Pangasinan has prepared their Supplemental Annual Investment Program for CY 2020. This was endorsed by the Council, through MDC Resolution No. 2, S-2020 dated February 24, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 21, S-2020 dated March 2, 2020;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment cost of P24,985,866.00, covers, among others, the salary increase and Performance-Based Bonus of municipal employees, MDRRM and GAD-related projects, and other development projects of the LGU;
