**RESOLUTION NO. 538-2019**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR  
CALENDAR YEAR 2019 OF BOLINAO, PANGASINAN  
INVOLVING A TOTAL APPROPRIATION OF  
P10,009,774.14 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2019 involving total appropriations of **P10,009,774.14** which was approved on August 20, 2019 through Appropriation Ordinance No. 2019-01;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2019 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007; and



**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 1 for Calendar Year 2019 of Bolinao, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Bolinao;
