RESOLUTION NO. 538-2022

DECLARING MUNICIPAL ORDINANCE NO. 04-2021 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING CHAPTER XI ARTICLE 3 SECTION 1 OF THE TOURISM CODE OF THE MUNICIPALITY OF BURGOS, PANGASINAN, GRANTING BARANGAY ILIO-ILIO 20% SHARE FROM THE COLLECTION OF ENVIRONMENTAL FEES COLLECTED FROM TOURIST VISITING DESTINATIONS WITHIN THEIR JURISDICTION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Ordinance No. 04-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Tourism and Cultural Affairs Officer, Provincial Budget Officer, and the Provincial Treasurer Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted and may be justified under the General Welfare Clause under Section 16 of R. A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—




