**APPROVING RESOLUTION NO. 33, S-2020 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF CALASIAO, PANGASINAN FOR THE YEAR 2020"**

**WHEREAS**, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 33, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Calasiao, Pangasinan has prepared the municipality's Supplemental Annual Investment Program for CY 2020. This was endorsed by the Council, through MDC Resolution No. 04, S-2020 dated March 19, 2020 to the Sangguniang Bayan for approval;

**WHEREAS**, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 33, S-2020 dated March 21, 2020;

**WHEREAS**, said Supplemental Annual Investment Program, which has a total investment requirement of P4,183,751.00, covers augmentation funds for Personal Services and MOOE of the LGU, to include projects and activities in response to LDRRM/COVID-19 crisis;


