WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Resolution No. 2017-102 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

This was endorsed thru MDC Executive Committee Resolution No. 2017-02 dated October 30, 2017 and was subsequently approved by their Sangguniang Bayan through Resolution No. 2017-102 dated November 6, 2017;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
