RESOLUTION NO. 540-2022

DECLARING ORDINANCE NO. 22-03 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “AN ORDINANCE AUTHORIZING THE HONORABLE JULIER C. RESUELLO, IN HIS CAPACITY AS THE CITY MAYOR OF SAN CARLOS CITY (PANGASINAN), TO PROVIDE FUNDS SUPPORTED BY A CERTIFICATION OF FUND ALLOCATION BY THE CITY TREASURER AND IMPLEMENTING OTHER COMPONENTS NOT COVERED BY NATIONAL HOUSING AUTHORITY’S (NHA’S) ASSISTANCE OR CONTRIBUTIONS OF OTHER PARTICIPATING INSTITUTIONS RELATIVE TO THE SAN CARLOS PLAINS-HOUSING PROJECT AT BARANGAY TARECTEC, SAN CARLOS CITY (PANGASINAN)”, AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 22-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 17 (b) (3) (viii) (4) and Section 18 of R. A. No. 7160, and is likewise consistent to Section 21 of R.A No. 7279 otherwise known as “Urban Development and Housing Act of 1992”;


