APPROVING RESOLUTION NO. 2022-63 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 02, CALENDAR YEAR 2022 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2022-63 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council-Executive Committee of Mangaldan, Pangasinan proposed for the reprogramming of the project: Variation Order for main Feeder Line of Agno Waste Treatment Facility in the amount of P1,385,000.00, to the project: Opening and Concreting of Guilig Farm-to-Market Road, both projects being included in SAIP No. 7, CY 2021 of the LGU. The reprogramming was included in their Supplemental Annual Investment Program (SAIP) No. 2 CY 2022 which was endorsed by the Council, through MDC Resolution No. 2, Series of 2022 dated March 9, 2022, to the Sangguniang Bayan for Approval;

2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱5,000,000.00, covers the project: Opening and Concreting of Guilig Farm-to-Market Road of the LGU;
3. Funding for the Supplemental AIP will be sources from the Reprogramming of the project: Variation Order for Main Feeder Line of Agro Waste Treatment Facility in Brgy. Banaoang in the amount of P1,315,000.00 and the P3,685,000.00 as the initial funding cost of the same FMR projects as included in SAIP No. 7, CY-2021 of the concerned LGU.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;


