APPROVING SB RESOLUTION NO. 105-2019 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 03-2018 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN IN THE AMOUNT OF THREE MILLION TWO HUNDRED THOUSAND (P3,200,000.00) PESOS”

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 105-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Malasiqui, Pangasinan has prepared the municipality’s Supplemental Investment Program No. 3 for CY 2018. This was endorsed thru MDC Resolution No. 03, S-2018 dated October 26, 2018 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 105-2019 dated July 17, 2019;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment requirement of P3,200,000.00, covers the Construction of Circumferential Road at Barangay Poblacion-Tambac of the said municipality;


