**PROVINCIAL RESOLUTION NO. 544-2021**

**INVITING ANEW THE PROVINCIAL HEALTH OFFICER, PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER, AND PROVINCIAL DIRECTOR OF THE PANGASINAN POLICE PROVINCIAL OFFICE TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS JUNE 21, 2021 REGULAR (PHYSICAL) SESSION TO UPDATE THE BODY ON THE PROGRAMS BEING UNDERTAKEN BY THE PROVINCIAL INTER-AGENCY TASK FORCE TO FURTHER COMBAT COVID-19 IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, the NCR plus has already been placed under a General Community Quarantine, however, there are reports of surge in number of COVID-19 cases in some provinces of the country;

**WHEREAS**, at present, there is a steady increase of COVID-19 cases reported in various parts of the Province;

**WHEREAS**, as of June 13, 2021, the Province of Pangasinan has registered a total number of 765 active COVID-19 cases;

**WHEREAS**, the Sangguniang Panlalawigan would like to hear directly from the Provincial Inter-Agency Task Force the ongoing measures and approaches being undertaken by the Province to fight COVID-19;

**WHEREAS**, some of the main issues and concerns that might be discussed during the Question Hour are the following: implementation of vaccination program and border control points, and status of isolation facilities in the Province of Pangasinan;



**NOW, THEREFORE**, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


