PROVINCIAL RESOLUTION NO. 546-2022

INVITING THE PROVINCIAL HEALTH OFFICER, PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER AND THE PROVINCIAL DIRECTOR OF THE PHILIPPINE NATIONAL POLICE, ALL OF THE PROVINCIAL INTER-AGENCY TASK FORCE (IATF) TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS MAY 30, 2022 REGULAR (PHYSICAL) SESSION TO UPDATE THE BODY ON THE STATUS OF COVID-19 IN THE PROVINCE

WHEREAS, the Province of Pangasinan is again placed under Alert Level 1 due to the lessening of COVID-19 cases and that several parts of the Province of Pangasinan have been recording zero active infections;

WHEREAS, social gatherings are already up again and that everything is back to normal so the people should be constantly reminded to observe the minimum public health and safety protocols as the threat of COVID-19 is just around the corner;

WHEREAS, the Sangguniang Panlalawigan would like to schedule again a Question Hour and invite the Members of the Provincial Inter-Agency Task Force (IATF) to shed light on the current situation of COVID-19 in the Province and the present direction of the Province towards further eliminating the disease;

WHEREFORE, in view of the foregoing, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


