APPROVING RESOLUTION NO. 138-S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 FOR CY 2020 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF SEVENTEEN MILLION EIGHTY-SIX THOUSAND TWO HUNDRED FORTY NINE PESOS (P17,086,249.00) FROM THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (LOCAL BUDGET CIRCULAR NO. 125)"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 138-S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council-Executive Committee of San Fabian, Pangasinan has prepared the municipality's Supplemental Annual Investment Program No. 1 for CY 2020. This was endorsed by the Council thru MDC Resolution No. 01, S-2020 dated April 21, 2020 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 138, S-2020 dated April 22, 2020;

WHEREAS, the said Supplemental AIP, which has a total investment requirement of P17,086,249.00 is intended to finance food assistance and other relief goods for COVID-19 affected households, Procurement of medicines, vitamins and other medical supplies for COVID-19 operations, Procurement of equipment, disinfecting tents, personal protective equipment (PPE) and other disinfecting supplies, food transportation, and accommodation expenses of medical personnel, frontliners and other LGU personnel directly involved in the implementation of COVID-19 and other necessary COVID-19 related PPAs and expenses of the LGU;
