APPROVING RESOLUTION NO. 78-2020 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 01 CALENDAR YEAR 2020 OF THE MUNICIPALITY OF ROSALES, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Resolution No. 78-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Rosales, Pangasinan has realigned the 20% development projects namely: Clean and Green Program (P2,000,000.00) and Beautification/Improvement of Parks and Plaza (P500,000.00) to COVID-19 emergency response measure namely: Food Assistance and other relief goods for affected families (P2,500,000.00). This is embodied in their Supplemental Investment Program No. 1 which was endorsed thru MDC Resolution No. 0408, S-2020 dated April 8, 2020 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said Supplemental Investment Program No. 1 through Resolution No. 78-2020 dated April 14, 2020;

WHEREAS, the project, food assistance and other relief goods for affected families is in accordance to DILG-DBM JCM No. 01 dated March 27, 2020 (Additional Guidelines on the Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects in view of COVID-19 Situation);
