DECLARING **ORDINANCE** NO. 068-2021 OF SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING FRANCHISE TO UNITED ASSOCIATION OF COCKPIT OWNERS AND OPERATORS OF THE PHILIPPINES INC. (UACOOP) TO **BROADCAST** LIVE AND **DATA STREAMED** COCKFIGHTING **ACTIVITIES** AND DERBIES COMMERCIAL ESTABLISHMENTS AND TO ESTABLISH, OPERATE AND MAINTAIN OFF-SITE COCKPIT BETTING STATION WITHIN THE MUNICIPALITY OF LABRADOR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Municipal Ordinance No. 068-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (a) (3) (v) of RA 7160 and Section 6 of Presidential Decree No. 449 otherwise known as the Cockfighting Law of 1974;

WHEREAS, subject ordinance shall take effect after the requirements of public hearing, posting and publication pursuant to Sections 187, 188, 59 (c) and 511 (a) of RA 7160 are complied with;
