APPROVING RESOLUTION NO. 83-2020 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 02 CALENDAR YEAR 2020 INVOLVING AN AMOUNT OF THIRTEEN MILLION SEVEN HUNDRED NINETY FIVE THOUSAND AND ONE HUNDRED FIFTY PESOS (P13,795,150.00) FOR PURPOSES OF THE BAYANIHAN GRANT OF THE MUNICIPALITY OF ROSALES, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Rosales, Pangasinan submitted its Resolution No. 83-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Rosales, Pangasinan has identified programs/projects/activities to address emergency response measures to COVID-19 PANDEMIC. This is embodied in the municipality's Supplemental Investment Program No. 02 which was endorsed thru MDC Resolution No. 0420, S-2020 dated April 24, 2020 to the Sangguniang Bayan for approval. This was approved by the Sangguniang Bayan thru Resolution No. 83-2020 dated April 24, 2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the said Supplemental AIP has an investment requirement amounting to P13,795,150.00 which will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA 11469 (The Bayanihan to Heal as One Act);
