APPROVING RESOLUTION NO. 2020-058 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) CY 2020 OF SUAL, PANGASINAN AMOUNTING TO ONE HUNDRED TWO MILLION EIGHT HUNDRED EIGHTY THOUSAND ONE HUNDRED EIGHTY-EIGHT PESOS AND 82/100 (P102,880,188.82)"

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2020-058 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991:

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program for CY 2020 with a total investment requirement of P102,880,188.82. This was endorsed to the Sangguniang Bayan for approval on February 29, 2020 thru MDC Resolution No. 07, S-2020 and was favorably acted upon by the Sangguniang Bayan on March 25, 2020 thru SB Resolution No. 2020-058;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers the fund augmentation for the Personal Services of all offices and Maintenance and Other Operating Expenses and Capital Outlay expenditures of some municipal offices, implementation of gender and development, disaster risk reduction programs and other development projects of the municipality;
