RESOLUTION NO. 556-2020

DECLARING THE SUPPLEMENTAL BUDGET NO. 02 FOR CALENDAR YEAR 2020 OF SUAL, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P64,661,634.25 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Supplemental Budget No. 02 for Calendar Year 2020 involving total appropriations of **P64,661,634.25** which was approved on March 25, 2020 through Appropriation Ordinance No. 03;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The funding source for the subject supplemental budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;

3. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
4. The full implementation of the First Tranche Compensation Adjustments for municipal officials and employees shall be subject to the provisions of Local Budget Circular No. 121 of the Department of Budget and Management dated January 24, 2020;
5. It is hereby reiterated that the previous finding of the salary grade allocation of the following positions should be adjusted to conform with the provisions of Budget Circular No. 2009-92 dated September 3, 2009, Annex "B" – Reallocated Classes of Positions:

<u>FROM</u>	<u>TO</u>
Medical Officer V – SG-22	SG-25
Medical Officer IV – SG-20	SG-23
Medical Officer III – SG-18	SG-21
Pharmacist I – SG-10	SG-11

6. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality and shall notify the offices concerned of the actions taken thereon;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera, Jr. and Margielou Orange D. Humilde, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 02 for Calendar Year 2020 of Sual, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Sual;


