CERTIFICATION

TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the special session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on December 12, 1996 at Lingayen, Pangasinan, the following resolution was approved:

EXPLANATORY NOTE

The present Sangguniang Panlalawigan is development-oriented Body. It does its legislative work by maintaining close coordination with local government officials, such as the Mayors, Vice Mayors, Councilors and the Sangguniang Bayan Secretaries.

As much as possible the Members of the Sangguniang Panlalawigan wants first-hand and direct information from the different local government units.

Although pursuant to law, the Sangguniang Bayan Secretaries are directed to submit within three days all approved resolutions, ordinances, executive orders, etc.. Nonetheless, the Sangguniang Panlalawigan Members also require the Sangguniang Bayan Secretaries to submit or furnish with copies of their ordinances and resolutions so that they be equipped outright information in relation to their review of said ordinances and resolutions.

In view of this, the Sangguniang Panlalawigan in session assembled enacted the following ordinance:

PROVINCIAL ORDINANCE NO. 56-96

AN ORDINANCE MANDATING ALL SANGGUNIANG BAYAN SECRETARIES TO PROVIDE WITH COPIES OF ALL ORDINANCES AND RESOLUTIONS PASSED AND APPROVED IN THEIR RESPECTIVE SANGGUNIANS, INCLUDING EXECUTIVE ORDERS, MEMORANDA OR CIRCULARS ISSUED BY MAYORS, TO THE DISTRICT BOARD MEMBERS

SECTION 1. This Ordinance is aimed to direct Sangguniang Bayan Secretaries to submit directly to the District Sangguniang Panlalawigan Members with copies of their ordinances and resolutions aside from the copies submitted to the Sangguniang Panlalawigan through the Sangguniang Panlalawigan Secretary.

SECTION 2. This Ordinance is aimed at providing the District Board Members concerned with first-hand or direct information on the legislative policies, administration and management of local sanggunians especially on legislative development programs of different municipalities.

SECTION 3. This Ordinance is in addition to the ordinances and resolutions to the Sangguniang Panlalawigan Secretary for the Sangguniang Panlalawigan as a legislative body for review purposes.

SECTION 4. The effectivity of this Ordinance is January, 1997.
