APPROVING RESOLUTION NO. 160, S-2017 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, "APPROVING ENTITLED THE **SUPPLEMENTAL** INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN FUNDED UNDER SUPPLEMENTAL BUDGET NO. 21 FOR CY 2017 AMOUNTING TO ONE MILLION NINE HUNDRED FORTY THOUSAND PESOS (P1,940,000.00) FOR THE MAINTENANCE AND OTHER **OPERATING** EXPENDITURES AND CAPITAL OUTLAY OF THE MUNICIPALITY OF BAUTISTA, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 160, Series of 2017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Bautista, Pangasinan has formulated the municipality's Supplemental Investment Program amounting to P1,940,000.00. This was endorsed thru MDC Resolution No. 03, S-2017 dated October 26, 2017 to the Sangguniang Bayan and was subsequently approved by their Sangguniang Bayan through Resolution No. 160, S-2017 dated November 14, 2017;
