**APPROVING RESOLUTION NO. 2021-071 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1, CY 2021 OF SUAL, PANGASINAN AMOUNTING TO FIVE HUNDRED EIGHT MILLION FIVE HUNDRED THOUSAND PESOS (P508,500,000.00)”**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its SB Resolution No. 2021-071 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of Sual, Pangasinan identified items in their Supplemental Investment Program No. 1 for CY 2021. This was endorsed to the Sangguniang Bayan of Sual on May 6, 2021 through MDC Executive Resolution No. 1, Series of 2021;

**WHEREAS**, said Supplemental AIP covers the LGU’s priority programs and projects and payment of loans;

**WHEREAS**, the proposed Supplemental Investment Program has a total investment requirement of P508,500,000.00. Funding support for the implementation of the same will be sourced from the loan proceeds of the LGU (P500M) and reversion of unused appropriation of various offices (P8.5M) which are embodied in their proposed Supplemental Budget NO. 1, CY 2021 which was enacted by the Sangguniang Bayan of Sual on May 17, 2021 through Appropriation Ordinance NO. 02;


**WHEREAS**, the Sangguniang Panlawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;


