APPROVING SB RESOLUTION NO. 090-2021 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, **"APPROVING** ENTITLED THE **SUPPLEMENTAL** INVESTMENT PROGRAM NO. 001-2021 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN IN THE AMOUNT OF ONE HUNDRED SEVENTY-THREE MILLION HUNDRED EIGHTY THOUSAND PESOS EIGHT (P173,880,000.00)"

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 090-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of Malasiqui, Pangasinan prepared the LGU's Supplemental Investment Program No. 1 for CY 2021. This was endorsed by the Council through MDC Resolution No. 01, Series of 2021 dated May 24, 2021;

WHEREAS, said Supplemental AIP which has a total investment requirement of P173,880,000.00 covers the payment of salaries and wages of newly-created positions, augmentation funds for MOOEs and implementation of priority development projects of the LGU;

> **WHEREAS,** funding support for the Supplemental AIP will be sourced from Savings, Unexpended LDRRM Fund, CY 2015 and from the proceeds of the loan from the Development Bank of the Philippines as embodied in the LGU's Supplemental Budget No. 01, CY 2021, which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 001-2021 dated June 2, 2021;

> WHEREAS, the Sangguniang Panlawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Malasiqui, Pangasinan;
