ALEGRIA ALMAJANO, PROVINCIAL FEDERATION PRESIDENT OF BARANGAY HEALTH WORKERS TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS JUNE 28, 2021 REGULAR (PHYSICAL) SESSION TO APPRISE THE BODY ON THE IMPLEMENTATION OF GRANTING SPECIAL RISK ALLOWANCE (SRA) TO HEALTH WORKERS

WHEREAS, Administrative Order No. 42 of the Office of the President authorizes the extension until the end of June this year the grant of Special Risk Allowance (SRA) to frontline public health workers;

WHEREAS, the funding for the continued grant of SRA will be sourced from Republic Act No. 11494 or the Bayanihan to Recover as One Act;

WHEREAS, the Province of Pangasinan recognizes the selfless and tireless efforts of public health workers who risk their lives and health in responding to the call of time during the pandemic;

WHEREAS, the Province of Pangasinan also recognizes the essential roles of barangay health workers in the promotion of basic rural health programs in their respective localities;

WHEREAS, barangay health workers are always in the forefront of the government's thrust in the implementation of its programs, projects and activities particularly in far-flung areas;

WHEREAS, it is the concern of the Sangguniang Panlalawigan that public health workers be duly recognized and given at least a token compensation of their dedicated services during this period of public health crisis;

WHEREAS, the presence of the invited guests would go a long way to help the Sanggunian in the enactment of legislative measures that would redound to the benefit of the people of Pangasinan especially in the grant of special risk allowance to public health workers;

WHEREAS, Section 20 of the Internal Rules of Procedure of the 10th Sangguniang Panlalawigan of Pangasinan provides that a Question Hour is the period of time allotted for members of the Sanggunian to ask questions from invited resource persons coming from both the government and private sectors, usually heads of offices, technical men and prominent individuals, primarily intended to seek information from the latter on certain matters that are of public interest and in aid of legislation;


