WHEREAS, in 2017 and 2019, the Province of Pangasinan has been fortunate to have received a 2-hactare lot and 1-hectare lot located in Burgos, Pangasinan from the Cabiles family through a Deed of Donation to where the Pangasinan Reformation Center and the PDRRM Training Center/Provincial Halfway House have been built, respectively;

WHEREAS, the 3rd donation consisting of a 2,842.80-square meter lot has been initiated again by the Cabiles Family to the Province of Pangasinan which shall be used as a right of way going to the PDRRM Training Center/Provincial Halfway House;

WHEREAS, the PDRRM Training Center/Provincial Halfway House will serve as processing center for former rebels while waiting to be enrolled at the Enhanced Comprehensive Local Integration Program (ECLIP);

WHEREAS, worthy projects such as the construction of the PDRRM Training Center/Provincial Halfway House in the Province of Pangasinan cannot be fully operational without an access road going to the area;



NOW, THEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


