APPROVING RESOLUTION NO. 2020-184 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN CALENDAR YEAR 2020 REQUIRING A TOTAL FUNDING OF FOUR MILLION NINE HUNDRED EIGHTY-FIVE THOUSAND TWO HUNDRED ELEVEN PESOS (P4,985,211.00)"

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2020-184 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Sta. Barbara, Pangasinan prepared the Supplemental Annual Investment Program (AIP) No. 2. This was endorsed by the Council, through MDC Resolution No. 2020-02, S-2020 dated April 15, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2020-184 dated May 4, 2020;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment requirement of P4,985,211.00 covers the implementation of the First Tranche Compensation Adjustment effective January 1, 2020 as per DBM's Local Budget Circular No.121 dated January 24, 2020, and augmentation fund for the MOOE of the Executive Department;


