PROVINCIAL RESOLUTION NO. 571-2021

APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2021

WHEREAS, presented for consideration is the Supplemental Investment Program No. 5 of the Province of Pangasinan as endorsed by the Provincial Development Council through PDC Execom Resolution No. 12-21;

WHEREAS, Supplemental Investment Program No. 5 contains other priority programs, projects and activities that are not included in the approved 2021 Annual/Supplemental Investment Programs of the Province of Pangasinan and which are deemed necessary in the improvement of the delivery of health and other services to help minimize the impacts of Covid-19;

WHEREAS, Supplemental Investment Program No. 5 contains the following: Personal Services Augmentation Fund, Maintenance and Other Operating Expenses and Capital Outlay of various provincial offices and implementation of the following priority projects: Construction of Diagnostic Center; Construction of 2-Storey Rehabilitation Building; Upgrading of Fire Detection and Alarm System and Sprinkle; Procurement of: Medical Waste Autoclave with Built-in Shedder, Brand New Fully-Equipped Ambulances, Brand New Covid-19 Transport Vehicles (Box Type), Brand New Service Vehicle (Pick-Up) for Disease Surveillance and Contact Tracing, Mobile Kitchen for Nutrition Programs, Reagents and Kits for Pangasinan Molecular Diagnostic Laboratory, Protective Personal Equipment (PPEs), and Various Hospital Equipment for the Hospitals in the province;

WHEREAS, the total investment requirement for the full implementation of this Supplemental Investment Program in the amount of Php429,948,650.00 will be sourced from reversion of the following: accounts payables, other payables representing excess collection from previous years and current appropriations (Php29,948,650.00) and from the province's loan proceeds from Land Bank of the Philippines under the Help via Emergency Loan Assistance for Local Government Units (HEAL) program (Php400,000,000.00);

WHEREAS, also embodied in this Supplemental Investment Program No. 5 are the details of various infrastructure projects funded from the CY 2021 20% Development and Non-Office Funds;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;


WHEREAS, after careful study of the said Program, this august Body finds it to be in order;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan of Pangasinan to approve, as it is hereby approved, the Supplemental Investment Program No. 5 of the Province of Pangasinan for Calendar Year 2021;
