**PROVINCIAL RESOLUTION NO. 572-2021**

**APPROVING THE ENHANCED LOCAL ROAD NETWORK DEVELOPMENT PLAN (LRNDP) FOR CALENDAR YEARS 2021-2025 OF THE PROVINCE OF PANGASINAN**

**WHEREAS**, presented for consideration by the Sangguniang Panlalawigan is the Enhanced Local Road Network Development Plan (LRNDP) for Calendar Years 2021-2025 of the Province of Pangasinan as endorsed by the Provincial Development Council through PDC Execom Resolution No. 04-21;

**WHEREAS**, LRNDP is an integrated five-year development plan for the sustainable development of local road networks and contains a prioritized list of investment for the local road sector that would address identified issues of the sector which will lead to the attainment of the local government's vision;

**WHEREAS**, local government units are required to prepare their Local Road Network Development Plan in order to participate in the Conditional Matching Grant to Provinces (CMGP) for Road Repair, Rehabilitation and Improvement Program of the Department of the Interior and Local Government (DILG);

**WHEREAS**, the CMGP is a program of the national government through the Department of the Interior and Local Government and Department of Budget and Management in order to fund and improve the management of local roads;

**WHEREAS**, the LRNDP is a requirement for the Province of Pangasinan to access funding for provincial road infrastructure development under the DILG's Conditional Matching Grant for Provinces' Program and Local Government Support Fund-Financial Assistance (LGSF-FA) for LGUs;

**WHEREAS**, the LRNDP which covers the period from 2021-2025 shall be updated and enhanced to integrate the following key considerations: Disaster Risk Reduction-Climate Change Adaptation (DRR-CCA), Environmental and Social Safeguards, Gender Equality, and Asset Management and Maintenance Strategies;

**WHEREAS**, the LRNDP shall serve as a development guide in order to support the sustainable growth of more specific local road network for the Province of Pangasinan;


