**APPROVING RESOLUTION NO. 2021-103 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2021 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 03 (SAIP NO. 03) OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO ONE HUNDRED THOUSAND PESOS (P100,000.00)"**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its SP Resolution No. 2021-103 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

**WHEREAS**, the Local Development Council of Alaminos had identified items in their Supplemental Investment Program No. 3 for CY 2021 which was endorsed to the Sangguniang Panlungsod through CDC Executive Resolution No. 02, Series of 2021 on May 5, 2021;

**WHEREAS**, said Supplemental AIP covers the purchase of materials for the constructions of line canal at Core Shelter Assistance Program (CSAP) at Barangay Victoria, which is proposed for funding by the FY 2021 Local Government Support Fund-Disaster Rehabilitation and Reconstruction Program (FY 2021 LGSF-DRRAP) in the General Appropriations Act, RA No.11518;
