RESOLUTION NO. 576-2019

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF SUAL, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P350,000,000.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Annual Budget for Calendar Year 2019 involving total appropriations of **P350,000,000.00** which was approved on August 6, 2019 through Appropriation Ordinance No. 01;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The projects funded under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re "Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects";

2. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2019 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;
3. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
4. The full implementation of the Fourth Tranche Compensation Adjustment for Local Government Personnel shall be subject to the provisions of Local Budget Circular No. 118 of the Department of Budget and Management dated January 15, 2019;
5. The appropriation for Productivity Enhancement Incentive shall be subject to LBC No. 2017-4 dated December 4, 2017;
6. The disbursement of appropriation for Performance-Based Bonus (PBB) of officials and employees shall be in accordance with the DILG-DBM Joint Memorandum Circular No. 2018-1 dated October 11, 2018;
7. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Risk Reduction and Management Fund (LDRRMF);
8. The salaries of Ali Christia Garcia, Nurse III, under the Municipal Health Office, shall be adjusted from SG-17/1 P398,976.00 to SG-17/1 P443,304.00 per annum;
9. The ordinance creating new positions under the Office of the Municipal Treasurer, Assessor and Agriculturist shall be submitted;

10. The positions under the Legal and Judicial Service are included in the list of re-allocated classes of position under Budget Circular No. 2009-92 dated September 3, 2009. The position title therefore of Legal Officer V, Salary Grade 24, should be changed to Municipal Government Department Head (Municipal Legal Officer) Salary Grade 24; *and*
11. The purchase of Motor Vehicle shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018 and its Implementing Guidelines under Budget Circular No. 2019-2 dated March 4, 2019, Amending Administrative Order No. 15, dated May 25, 2011, and DILG Memorandum Circular No. 2014-155 as amended by DILG Memorandum Circular No. 2015-52 dated May 11, 2015, and Budget Circular No. 2017-1 dated April 26, 2017 re: Amending Budget Circular No. 2016-5 dated August 22, 2016.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Annal Budget for Calendar Year 2019 of Sual, Pangasinan** as of January 1, 2019; subject however to posting requirement under Section 59 of RA 7160; and provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Sual;




