APPROVING RESOLUTION NO. 162, S-2020 OF THE SANGGUNIANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED “APPROVING THE REALIGNMENT OF SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (P7,500,000.00) FROM THE TWENTY PERCENT (20%) LOCAL DEVELOPMENT FUND (LDF) OF THE LOCAL GOVERNMENT OF UMINGAN TO BE UTILIZED FOR THE PURCHASE OF RELIEF GOODS FOR AFFECTED HOUSEHOLDS IN THE MUNICIPALITY OF UMINGAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Umingan, Pangasinan submitted its Resolution No. 162, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Umingan, Pangasinan has endorsed through MDC Resolution No. 3, S-2020 dated April 6, 2020 to the Sangguniang Bayan for approval the realignment of the 20% development fund project namely: Rehabilitation and reblocking of Barangay Diaz FMR (P4,500,000.00) and Construction of Municipal Building (Conference Hall with canteen) (P3,000,000.00) to the Purchase of Relief Goods for affected households in the municipality of Umingan (P7,500,000.00) as emergency response measure to COVID-19 pandemic;
