APPROVING RESOLUTION NO. 163, S-2020 OF THE SANGGUNIANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2020 OF THE LOCAL GOVERNMENT UNIT OF UMINGAN PROVIDING THE PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) TO BE FUNDED BY THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) IN THE TOTAL AMOUNT OF EIGHTEEN MILLION THREE HUNDRED NINE THOUSAND THREE HUNDRED SEVENTY-SIX PESOS (P18,309,376.00)"

WHEREAS, the Sangguniang Bayan of Umingan, Pangasinan submitted its Resolution No. 163, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Umingan, Pangasinan has formulated, adopted and endorsed the municipality's Supplemental Annual Investment Program thru MDC Resolution No. 4, S-2020 dated April 11, 2020 to the Sangguniang Bayan for approval. This was approved by the Sangguniang Bayan thru Resolution No. 163, S-2020 dated April 20, 2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental AIP with an investment requirement amounting to P18,309,376.00 covers programs/projects/activities to address emergency response measures to COVID-19 pandemic. This will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA 11469 (The Bayanihan to Heal as One Act);


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
